### Contract for Instrumental Tuition – 2024/25 Academic Year

1. I wish for my child to receive music/instrumental tuition from September in the 2024/25 academic year.
2. I understand that this tuition will commence, from September, as face to face tuition, this tuition will continue unless any Covid-19 restrictions come into force where learning will revert to online learning.
3. I understand that any school-based tuition will involve my child being withdrawn from classroom lessons, during college hours, on a rota basis, to receive tuition.
4. I agree to pay £255.00 for the 2024/25 academic year. The payment schedules available are:
  - a. Full payment - payment of £255.00 due by 1st October 2024.
  - b. Termly – three instalments, the first payment of £85.00, due by 1st October 2024, a second payment of £85.00 by 10<sup>th</sup> January 2025, and a third payment of £80.00 by 4th April 2025.
  - c. Monthly - subject to agreement, a minimum of £25.00 per month until the balance is nil. The first payment must be paid by 1st October 2024.
  - d. Weekly – subject to agreement, a minimum of £12.00 per week, until the balance is nil. The first payment must be paid by 1st October 2024.If you opt to pay monthly or weekly, these must be paid promptly every week or month as agreed. Full and final payment must be made by no later than Friday 27th June 2025.
5. Please note that fees are pro rata if your child commences tuition part way through academic year.
6. I understand that keyboard/piano and drum lesson students cannot be provided with an instrument to loan / take home. All other instrumental disciplines would be issued with an instrument at the start of the academic year.
7. I understand that the college reserves the right to discontinue the tuition, and should this be the case, no refunds will be made in respect of any tuition already delivered.
8. I understand that every effort will be made to allow my child to change instruments if they so wish.
9. I understand that I am entering into a financial commitment for the academic year and understand the expectations for payment. I also accept that the college reserves the right to withdraw my child from music tuition if the agreed payment schedule is not met and that I will still be liable for the full payment for the academic year. Please note that the College will seek recovery of payment through the County Court, if necessary.
10. Once this agreement is signed it is binding for the full academic year and cannot be cancelled.
